After reviewing all shots and speaking to drivers Colin Kelly and Denis St. Pierre it was determined that # 3 is bearing in and is not forced inside the pylons by # 4. As a result, # 3 finished 2nd and was placed 3rd for the pylon violation. No penalty to driver Colin Kelly as the horse is bearing in.
