R3 & R7 - Ontario Sire Stake, 3yo filly Trot

**Races:**

R1- INQUIRY. Reviewed pylons after the 1/2 on #6 Brydown Better Bea (Tre Henry, 3<sup>rd</sup>) and after the start on winner #2 Ardyne Graysee (J. Drury). Drivers were tight to the pylons but not inside.

R2 – Reviewed pylons after the start on #8 Charmbo Joy (T. Borth, 2<sup>nd</sup>). Not inside.

R3 – OSS - INQUIRY. #2 Lucy Who (JB Renaud) finished 3<sup>rd</sup> and was placed 4<sup>th</sup> for failing to continuously lose ground while off stride in the stretch, as per [rule 22.27.01](#). #2 must qualify for breaks. The Paddock Judge was notified. Reviewed pylons in the last turn on winner #1 Its Your Choice (J. MacDonald). #1 hit three pylons but was not inside them. No violation. Reviewed the breaks on #3, #4 and #7.

R4 - Reviewed pylons in the first turn on #6 Meilleur Fromage (B. McClure, 4<sup>th</sup>). No violation.

R5 – INQUIRY. Reviewed the start where #1 Southwind Grizzly (C. Graham, 3<sup>rd</sup>) makes a short break in stride but does not cause interference to the trailing horse. No violation.

R6 – Clear.

R7 – OSS – INQUIRY. #3 No Angle Like Me (S. Lacaille) went off stride before the start and was outside the fair start pole when the field reached the start line. Parimutuel refund on #3 was \$221.38.

R8 – INQUIRY – Winner #3 YS Bettors Legacy (D. Thiessen) went off stride before the finish and was lapped on by #4 and #6. #3 finished 1<sup>st</sup> and was placed 3<sup>rd</sup>.

R9 – Clear

R10 – Travis Henry was unable to fulfill his driving engagement in this race and was issued a \$50 monetary penalty. Ruling #2339424
