

Report on day's events:

Test strips utilized. (Race 1)

Trainer David Menary was assessed a \$200 monetary penalty for violation of AGCO Rule 20.03.01, stable error scratch of three horses, Ikes Dream, Joker On Jack and Coop A Loop.

Races:

Race 1: Reviewed racing in deep stretch when #2 Northern Charlotte (C.Christoforou), finished 4th, put in a couple steps. The horse's nose touched the helmet B.McClure who was directly in front of #2 Northern Charlotte.

Race 2: Clear.

Race 3: Reviewed the breaks of #1 Northern Magenta (stretch) and #5 No Angel Like Me (before the start). Both horses must qualify for breaks.

Driver Scott Young was found in violation of AGCO Rule 22.03(j)(v), crossing over before the start while driving Sweet Carrie T, \$200 monetary penalty. Ruling #2358804.

Race 4: Driver Trevor Henry was found in violation of AGCO Rule 22.05.01(e), did allow another horse to pass needlessly on the inside in the stretch while on the lead, \$200 monetary penalty. Ruling # 2358801.

Race 5: Clear.

Race 7: #6 Cassius Hanover finished 7th and was placed 8th for a lapped on break at the finish.

Race 8: Clear.

Race 9: **Inquiry:** #1 Enzo Aguello made a break before the start but was well inside the fair start pole.

Race 10: Reviewed racing from the quarter to the half mile mark. No violations.

Race 11: Driver Nick Boyd was found in violation of AGCO Rule 22.23.03(b), did use more than wrist action while urging, ruling to be generated tomorrow.

Race 12: #5 Sunshine Sally (Trev.Henry), finished 9th, and #6 Voelz Delight (T.Jones), finished 5th, came together in the stretch, no violations.
