- Reviewed race pace (28 59 127³ 156⁴) concerning the #1 GODIVA ICE CREAM (Guy Gagnon); considering the class, that #1 was two lengths in front and the trailing horses were not impeded the panel does not consider this to be a violation of AGCO rule 22.05.01(k) (pace comparable to class). Clear.
- The #7 THE COLT (Gordon Ley) broke before the ¼ mile pole, fell, did not finish and must qualify for performance (trainer notified); the #7 was examined by AGCO veterinarian Dr. L. Berthiaume Atack who reported only minor abrasions; Mr. Ley was examined by paramedics who determined no injury. Clear.
