Office:

- **Note**: As of 17 November, the AGCO will resume alcohol screening using breath analysis (breathalyzer) testing of participants in all safety sensitive positions (e.g., drivers, trainers, track employees, etc.). Drivers will be required to arrive at the paddock one hour prior to their first drive of the night to provide a breath sample.
- Early veterinary scratch (sick) of LYONS SHINE ON the first race; this horse is entered on the short term (seven days) Veterinarians list.
- Discussed enhancing the accident horn sound level with Racing Manager Peter Andrusek.

Qualifiers:

- In the first qualifier #4 BEAUMONT KELLY (Jimmy Gagnon) fell after the start, unseating the driver; Mr. Gagnon reported no injury and was deemed fit to continue racing; #4 was trailered off the track.
- Drivers Guy Gagnon, Kyle Forgie, Dan Murphy and Antonio Vecchio were reminded that all horses are required to cease racing and pull up when the warning lights are flashing and accident horn is sounded.
