## Office:

- Early Judges scratches (ineligible) of CAFÉ SOCIETY and TWOMACSONEMACH from the seventh race.
- Discussed EIPH program requirements with trainer Steeve Fortin; regulatory submissions to enter, or remove, a horse from the EIPH program may only be affirmed by a veterinarian holding a valid AGCO licence.

## Races:

- Jacques Beaudoin excused from one drive.
- Recall as #5 BEAUSOLEIL FAMILY (Kyle Forgie) would not turn; this horse was subsequently a Judges scratch and a parimutuel refund (\$4025) as the driver was kicked at several times and contacted once and did not wish to take additional risk: Mr. Forgie was examined and reported no injury; trainer Dany Lepage was advised to remedy this problem before entering this horse again. Clear.
- 2. Inquiry on #5 BATTLE OF YORK (Stephane Pouliot) concerning a possible passing lane violation; after reviewing the race video and speaking with the driver of the trailing horse #2 RED CARPET READY (Philip Reid), who finished second, it was determined that #5 did not maintain a straight course in the stretch, did enter the passing lane and thereby violate AGCO rules 22.05.02.2(ii) (maintain a straight course allowing full

access to the passing lane to trailing horses) and 18.08.02(c) (leaving the course); #5 finished first placed second (AGCO rule 22.09).

- 6. The #5 DO YOU SEE IT (Stephane Pouliot) suffered broken equipment (head pole) at the ¼ mile pole and finished with broken equipment. Clear.

- 8. Reviewed the break (stretch and finish) by #6 OFFICER JONES (Samuel Fillion) who finished seventh; no violation of the breaking rules and #6 was not lapped on; no placing. Clear.
- 9. Recall as #8 THE LIGHT SPEED (Guy Gagnon) would not turn.
  - Inquiry concerning possible interference at the top of the stretch; after reviewing the race video it was determined that #8 did bear in and hook wheels with #3 DYLANS BANK (Jimmy Gagnon) causing interference to the remainder of the field (all horses charted with interference); #8 finished seventh placed eighth for causing interference to #3 (AGCO rule 22.09). Driver Guy Gagnon will attend a review regarding a possible violation of AGCO rule 22.05.01(h) (strike or hook wheels with another sulky). Clear.
- 10. Driver of #8 THRILLING TIMES, Jason Gilchrist, was cautioned regarding his urging in the stretch. Clear.
