- Last program of the 2023 Rideau Carleton racing season.
- Documentation was submitted to remove WOODMERE BANKROLL in the tenth race from the EIPH program; this request was denied as per AGCO rule 35.12 a horse entered on the EIPH program is ineligible to be removed for a period of 100 days; this horse was administered Lasix prior to racing.
- Virtual review held with driver Guy Gagnon concerning THE LIGHT SPEED from race 9 on 19 November concerning possible interference to DYLANS BANK (Jimmy Gagnon); Mr. Gagnon was adjudged guilty of violating AGCO rule 22.05.01(h) (strike or hook wheels with another sulky) and assessed a three day driving suspension (19-21 December, inclusive) (Number 2471314).
- Early veterinary scratches (sick) of BEACH ROLLER in the third race and ARTSFIRE from the sixth race, and DEAR BIRDIE and UBER HANOVER from the tenth race; these horses are entered on the short term (seven days) Veterinarians list.
- Discussed interactions with Association staff with driver Mike Healey regarding the requirement that all persons behave in a respectful and professional manner at all times.
