### RACES

Race 1 – All Clear

Race 2 – Reviewed the break by #2 Havurcakeneatittoo (Martin Lachance) after the start, finished 5<sup>th</sup> – no violations of the AGCO breaking rule.

Race 3 – Inquiry – Reviewed racing in the stretch between #3 Outlawskysthelimit (Travis Cullen) and #6 Happy Looker (Samuel Fillion). The front tower video shows #3 is running out in the stretch and puts a wheel under #6. The low pan video shows the wheel of #3 stops and impedes the progress of #6. The pan video shows where Fillion is forced to check his horse. The Panel ruled #3 caused interference to #6; #3 finished 1<sup>st</sup> placed 2<sup>nd</sup>.

Race 6 – Reviewed the breaks by #8 Had Me A Whiskey (Bruce Richardson) after the start and half, finished 5<sup>th</sup> – no violations of the AGCO breaking rule by #8.

- #1 Whats The Point (Travis Cullen) was charted with an 'ix' due to the break by #4 Willy Windmill (Dan Megens) in the first turn, no placings needed.

- #6 Synergy S (Scott Coulter) pulled up after the half with broken equipment (overcheck). The horse was observed by Association Vet Dr. Stovman following the races and reported OK.

Race 7 – All Clear

Race 8 – Inquiry – Reviewed the break by #2 Fastnet Rock (Travis Henry) in the stretch, finished 4<sup>th</sup> – #2 is off-stride through the wire, double lapped by #4 Sollwitt (Brett Macdonald) and #6 Electro Long Legs (Paul MacKenzie). #2 finished 4<sup>th</sup> placed 6<sup>th</sup> for a double lapped-on break at the finish.
