- Drivers Jody Jamieson and Bob McClure were excused from his drives this evening.
- Driver Anthony Haughn was found to be in violation of AGCO rule 6.02 (a) (failure to drive when programmed and not excused by the Judges) and is subject to a \$100 monetary penalty. Ruling #2505401
- Races with the condition listed as non winners of an Ontario Sired amount still receive a twenty-five percent Ontario Sired allowance for that listed amount.

R1 – #9 Dancing Dover (Tyler Borth), (finished tenth) was distanced and was placed on the Judges list for performance and must qualify.

R2 – Reviewed #3 Watch Your Tone (James Macdonald), (finished fifth). It appears that #3 put in some steps midway in the stretch. Driver James Macdonald stated

that the gelding was wearing a smaller shadow roll than he normally wears. No violations occurred.

R3 – All clear.

R4 – All clear.

R5 – All clear.

R6 – The Judges reviewed racing just before that three-quarter pole. #1 Quentin Quarantino (Doug McNair), (finished eighth) jumped over a small clump of material on the track and was charted with an interference break. #4 Cobra Creek (Sylvain Filion), (finished fifth) was charted with interference as #4 avoided the #1.

R7 – Slight delay to the start of this race for track maintenance.

- Breathalyzer retest race.

R8 – #5 Dialmeup (Tyler Borth), (finished seventh) finished with broken equipment (lost a shoe).

R9 – All clear.

R10 – Judges inquiry, reviewed pylons at the top of the stretch. #2 Miss Dew Write (James Macdonald), (finished fifth). #2 was inside one pylon and hit another. No advantage was gained when going inside one pylon.
