Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Rideau Carleton employee Matt Donald attended the Judge's Office to provide a statement regarding an incident at the qualifying races on 17 April.
- Following an inquiry by a participant, discussed condition allowances for Ontario sired horses with Race Secretary Ian Fleming; the allowance applies to both purse earnings and supplementary conditions.
- Review with driver Melanie Plourde concerning her urging of CANDID CAMERON in the tenth race on 21 April; after reviewing the race video and discussing compliance with the urging rules no further action is required at this time; official warning entered on the licence of Ms. Plourde.
- Review with driver Stephane Pouliot concerning his urging of RAISING RUSTY in the eleventh race on 21 April; after reviewing the race video and discussing compliance with the urging rules no further action is required at this time; official warning entered on the licence of Mr. Pouliot.
- Trainer Macy Cassell attended the Judge's Office to discuss backstretch security during the races.

Races:

1. The #6 DA CAPTAINOBVIOUS (Jacques Beaudoin) suffered broken equipment (knee boot) after the start and finished with broken equipment. Clear.

2. Inquiry on #6 JON SNOW (Ryan Guy) who broke stretch and finish and finished fourth; #6 was lapped on by #3 ODDS ON WALKOVER (Darcy Clancy); #6 finished fourth placed fifth (AGCO rule 22.27). The #6 was examined by the AGCO Veterinarian Dr. Melissa Rocheleau post race and found to be asymptomatic. Clear.

3. Driver of #5 SHADOW DAVE, Mike Healey, was cautioned regarding carrying his whip perpendicular to his horse and in front of #6 CENTURY JAZZ (Stephane Pouliot) in the stretch. Clear.
4. Reviewed the performance of #5 IRRESITIBLE (Robert Shepherd) in the stretch; #5 was rough for a few strides but did not break. Clear.
