41st Annual Charity Driver Challenge (1st - Trevor Henry, 2nd – Bob McClure, 3rd Natasha Day)

The early vet scratches of BLUE WATER BEACH from the first race, KEIRAN from the third race, and WINKYS PRIDE from the eighth race were all added to the short-term Vet List.

## Races:

R1 - Clear.

R2 – Clear. #5 EGREMONT OLLIE was out distanced (41 lengths) and must qualify for performance. Trainer Dwayne May notified.

R3 - Clear.

R4 - Clear.

R5 – #3 MOONLITEBEACH (J. Jamieson) pulled up after ¾ and did not finish. The Official Vet checked the horse and added it to the Vet List (sick). The horse was also added to the Judges List for Performance and must qualify.

R6 - INQUIRY - #3 DEADLY ACTION (B. MacDonald) bore in and was inside more than three consecutive pylons in the final turn. #3 finished fourth and was placed last as per AGCO rule 18.08.02 (b).

R7 – INQUIRY - #8 DIAMONDS OR TWINE (J. MacDonald) was inside three consecutive pylons in the first turn (horse had steering issues). #8 finished 3<sup>rd</sup> and was placed last as per AGCO rule 18.08.02 (b).
