Ontario Sired Stakes – Three Grassroots Divisions for 3-year-old pacing colts.

Prospect Series – Two Divisions for 3-year-old pacing colts.

As per Rule #6.11 allowed to drive in stake races only. (Ontario Sired Stakes and Prospect Stake...races 5,6,7). AGCO rule #1276520, Mr. Rankin is now suspended an additional driving suspension August 5, 2021.

Races:

Race #1 – All clear

Race #2 – All Clear

Race #3 – #2 "Dr Joe" makes a break early behind the gate, does get back on stride but unable to get to the gate prior to the start (4- 5 lengths back). Charted with break, must qualify for breaks (3 breaks in a row), entered on iAGCO.

Race #4 – "Inquiry" top of the homestretch. #1 "Iam What I Am" (Marc ST LOUIS JR) does come out causing interference to #2 "Dustylane Thunder" (Alfie CARROLL). #2 does make a break in stride and charted with an "IX".

#1 finished 1^{st} and was placed 5^{th}

ST LOUIS did state the horse was running in then quickly stepped out giving no warning, and he corrected immediately. Film does support ST LOUIS statement, the Judges accept Mr. ST LOUIS explanation. No penalty.

Spoke to trainer Joseph SHAW and he stated he will add a headpole to the outside to correct the issue.

Race #5 – "Inquiry" before the ¹/₄ pole. # 4 "West Coast Kid" (Robert DOYLE) does move in and causes interference to #2 "Dragon Teen" (Donnie RANKIN JR.).

#4 finished 3rd and placed 4th.

Robert DOYLE – Violation of AGCO rule 22.05.01(a) – 3 day driving suspension August 21, 22, 23, 2021. Ruling #1276658.

Race #8 – "Inquiry" at the ¼ pole. #4 "P L Oliver" (GAGNON) and #2 "Sights on You" (MACKENZIE) hooked wheels. MACKENZIE stated his horse got running out ... film does support his statement. No change as #4 does beat # 2...#2 finished last. Interference given to all horses.
