

After reviewing the video and talking to drivers Marc St Louis Jr and Donnie Rankin Jr. it was determined that #2 "Eataamsbettershark" St Louis Jr made a break causing confusion to the field of horses. #2 finished 7th placed 8th, causing interference while on a break. #1 and #4 interference breaks and interference to #5, 6, 7 and 8. Film supports that #2 broke on his own while #3 "A Positive Hanover" Don Rankin Jr was clear on the outside. #5 "Woodmere Wyldstyle" Tyler Borth finished 4th, lost a shoe.
