The Judges held a paddock meeting to remind the drivers that we owe the racing fans fair and professional conduct. We reviewed some of the new rules related to breaks in stride, trailing horses and qualifying. We also discussed urging, feet contacting the horse, giving holes, pulling and failing to advance, slow quarters and post parades.

Races:

R1 – Reviewed the break of #1 VIVA LA DEO (A. Haughan, 5th). The horse was off stride through the finish and was not lapped. No placing necessary.

R2 – Clear

R3 – Nicholas Steward was notified that his foot was making contact with his horse after the start of the race. The Judges have sent Steward a link to the video for review.

R4 – Recall. #4 SHIELAS BRUSH (K. Oliver) interfered with #5 PDQ HANOVER (A. Sorrie) before the start causing a recall.

R5 – Reviewed pylons in the first two turns on #1 CHUCK HEATON LOVE (N. Steward, 3rd). Inside one pylon and over one pylon in each turn. No advantage gained. No violation.

R6 – Reviewed racing after the half for a possible break in stride on #7 MIDIROSE (B. MacDonald, 7th). The horse gets rough on the turn but does not break stride.

R7 – Reviewed racing at the head of the stretch. #4 DURHAM TOWN (T. Henry, 3rd) was over one pylon (not inside). No violation. Breath strip utilized pre-race.

R8 – Clear. Breath strip utilized pre-race.

R9 – #3 MAGNITUDE TEN was incorrectly programed without hobbles. The correction was announced and posted on the TV and added to the chart line. The early vet scratch (sick) of SHAMMIE HALL was added to the short-term Vet List. The rest of the race was clear.

R10 – Clear.
