### Races:

Race 1 – Inquiry: #5 TJ Spitfire (Colin Kelly, 1<sup>st</sup>) slowed pace excessively in the 2<sup>nd</sup> quarter causing confusion coming to the half. Spoke to drivers Colin Kelly, Scott Young (#1 Riverside, 3<sup>rd</sup>), Travis Henry (#3 Signing Bonus, 6<sup>th</sup>) and Paul MacKenzie (#7 Tango Seelster, 8<sup>th</sup>) who all stated that the horses got jammed up coming to the half but are also green two-year olds. No placings.

Driver Colin Kelly issued a \$100 monetary penalty for failing to maintain a pace comparable to the class of horses and track conditions (AGCO Rule 22.05.01(k)). Ruling #1280341

Race 2 – Inquiry: Reviewed breaks on #5 Victoriahasasecret (Scott Young, 3<sup>rd</sup>), #3 youcouldbethatgirl (Ryan Desroches, 4P6) and #4 Archie Hill (Steve Hudon, 6P5) after the start. #5 did not violate the breaking rules. #3 caused interference to #4 while off stride

causing #4 to break stride. #3 placed for causing interference. Also reviewed break on #2 D J Roy Hall (Austin Sorrie, 5P4) at the top of the stretch. #2 went inside the safety lane for clearance while off stride and returned to the racing surface when it was safe to do so. No advantage gained and no violations.
