Race 3 Judges inquiry in the stretch, #6 Pull Me Through finished 1<sup>st</sup> and paced 7<sup>th</sup> for causing interference in the stretch. #6 comes off the pylons to the 2 wide path and is fine but then comes out again and causes # 5 Ship Across to shorten his stride and go sideways into # 4 Putyourbettdown and #2 Sauble Amber. Race 5 #6 Brooklets Justified drifts off the pylons at the top of the stretch and hooks wheels with #10 On Cruise Control and causes interference to #1 Toxicity. #6 finished 8p10

Also #7 Handsome Sebastian finished 3<sup>rd</sup> and placed 4<sup>th</sup> for pylon violation at the top of the stretch. Inside 2 pylons and lapped by #2 at the finish.
