- Early Veterinary scratch (sick) of BOSTON BLUE from the first race; this horse is entered on the short term (seven days) veterinarians list.
- Early Judges scratch (injured) of UNDERCOVER STRIKE from the tenth race.

emergency lights and siren were activated and the race declared no contest (AGCO rules 22.32.02 and 22.33); refund: \$13,623. #2 was examined by the AGCO veterinarian Dr. Melissa Rocheleau who reported the horse to be in good health; Samuel Fillion was examined by Emergency Medical Personnel, removed from his remaining drives and transported to the hospital for examination.
