Race 1 # 8 KD Roses (R. Desroche) was distanced. # 8 was examined by the Commission Vet and placed on the Vets list short term sick. # 8 is also on the Judges list for performance and must qualify.

Race 2 Inquiry. Reviewed breaking horses before the start. # 5 Glandcaster Hall (C. Kelly) was inside the fair-start pole. # 1 My Old Stud Leroy (A. Moore) was not inside the fair-start pole and was refunded. Refund amount \$1,707. Also, reviewed break by # 4 Satin Pajamas (J. Obrien) going to the ¼. # 3 Road To Redemption (M. Budway) was charted with an interference break. No placings needed.

Race 3 # 4 Jackieofalltrades (A. Haughan) did stop badly after the ½, pulled-up and did not finish. It was reported that the horse choked. # 4 must qualify for performance. # 7 Perfect Romi (S. Lacaille) was charted with interference after the ½.
