



## **Enter to Win A Share in a Racehorse! -Contest Rules**

### **Eligibility**

1. To participate in the contest, entrants must be 18 years of age and over, as of the contest date on which they are entering, and must be a permanent resident of Ontario.
2. Entrants and members of their immediate household may not have owned a Standardbred racehorse nor be a member of Standardbred Canada now or in the past 5 years.
3. Employees, and members of their immediate household of the OLG, Ontario Racing, AGCO, Standardbred Canada, any Canadian racetrack and racing commission are not eligible.

### **Contest Format**

4. Contest entry is open to people attending New Owners Seminars at Mohawk Racetrack on Sept. 23 and The Raceway at Western Fair District on Oct. 6. Contest entry is open to people attending the London Selected Yearling Sale on Saturday, October 14 from 9:30 a.m. through 5:30 p.m. and on Sunday, October 15 from 9:30 a.m. through 3:00 p.m. (provided they meet the criteria of #1, #2, #3 above).
5. Contest entry is limited to one ballot per person.
6. The winning ballot will be drawn at the offices of Standardbred Canada on Monday, October 16.
7. Contest winner must sign an agreement with LandMark 11 to officially start their involvement.

### **Grand Prize**

8. The Grand Prize is one share in LandMark 11 Stable, valued at \$2,000. On December 15, 2018, the winner will have the opportunity to terminate their participation in LandMark 11 (at no cost). The winner is entitled to any share related purse monies earned by horses in LandMark 11 Stable, up until December 14. If the winner chooses to continue their participation in LandMark 11, then he/she becomes fully responsible for any financial responsibilities as outlined in the LandMark 11 agreement.
9. The Grand Prize must be accepted as awarded, is not transferable and has no cash value.
10. The winner is required to complete an application form and meet all of the necessary requirements in LandMark 11. The winner also agrees to terms and conditions set out by LandMark 11. After the winner takes possession of the share, no guarantees of any kind exist. Selected winner will never take actual possession of any horses. The winner will be responsible for the cost of his / her personal licensing and memberships related to the horse ownership share.
11. The awarding of the Grand Prize is subject to conditions, including the eligibility of the winner to be licensed by the AGCO. Should the Grand Prize Winner be unable to fulfill any of these conditions, the entrant drawn as the First Runner Up will be awarded the Grand Prize. Should the First Runner Up be unable to fulfill any of these conditions, the entrant drawn as the Second Runner Up will be awarded the Grand Prize (subject to fulfilling the conditions).

### **General Rules**

12. Email addresses obtained through the balloting process will be used to communicate with the entrants regarding the Contest and may be used by the Ontario Sires Stakes for marketing purposes or to provide information to them as deemed appropriate. Personal information which is collected will not be sold, distributed or used for any other purpose except as described above. 13. All entries become the property of the Ontario Racing Association and Ontario Sires Stakes Program, will not be acknowledged as received and in no case shall be returned to the entrant.
14. Any ballot entry submitted or obtained through fraudulent means or which is in any way tampered with, will be disqualified. Ballots not completed in full may be rejected.

15. Ontario Racing Association and Ontario Sires Stakes Program, LandMark 11, London Selected Yearling Sale are not responsible for damaged, garbled, illegible, destroyed, lost, stolen, unreadable, inaccurate or incomplete entries.

16. Any injuries, losses, or damages of any kind caused by the prize or resulting in the acceptance, possession or use (including, but not limited to, the attendance of the track) or misuse of any prize or from participating in the contest is not the responsibility of the Ontario Racing Association, Ontario Sires Stakes Program, LandMark 11, London Selected Yearling Sale, Mohawk Racetrack or The Raceway at the Western Fair District.

17. Any entrant who at any time violates the official rules of the contest will be disqualified immediately and without notice. Ontario Racing Association and Ontario Sires Stakes Program, LandMark 11, London Selected Yearling Sale and participating tracks can disqualify participants if they do anything to undermine the contest by cheating, hacking, deception or any other unfair practices. Any and all disputes, claims, and causes of action arising out of or connected with the contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action.

18. The Ontario Racing Association and Ontario Sires Stakes Program is not responsible for printing, distribution or production errors and may terminate, modify or withdraw the Contest at its sole discretion, without liability and without notice, if it or any related material, are found to contain such errors.

19. All prizes must be accepted as awarded and may not be redeemed for cash.

20. Entrants agree to abide by the Official Contest Rules and Regulations and the decisions of the Ontario Racing Association and Ontario Sires Stakes Program and draw judges, which are final.

21. No purchase necessary. A skill-testing question is required.

22. By participating in the contest, entrants consent to the use of their name, address (city and province), biographical information and their portrait, picture, voice and/or likeness used for news and/or advertising and promotional purposes on a variety of mediums including the Internet, without compensation, except where prohibited by law. All forms of media, now known or hereafter devised, including the Internet, may be used by the Ontario Racing Association, Ontario Sires Stakes Program in any publicity or advertising carried out by the Ontario Racing Association and Ontario Sires Stakes Program relating to the Contest.

Anything not covered in these rules will be ruled on by the management of the Ontario Sires Stakes, Ontario Racing and Standardbred Canada and their decision will be final and binding.

Contestants, by entering the contest, agree to be bound by the above rules and regulations.
